SELECTION	Finalist selected by Commission Print Coordinator from Artist Pool consisting of Board-approved Artist Members from this Open Call. Final selection takes into account artist's availability and willingness to execute project in a timely and superlative fashion.
DEADLINE	Edition due NOVEMBER 25, 2011
